TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT (this "**Release**") is made as of October 18, 2011 by KEYBANK NATIONAL ASSOCIATION, as administrative agent for certain financial institutions ("**Agent**") in favor of the Credit parties (as defined below).

WITNESSETH:

WHEREAS, Agent, Roll Coater, Inc., an Indiana corporation ("**Borrower**"), Roll Coater Acquisition Corp., a Delaware corporation ("**Holdings**") and Roll Coater Holdings Corp., a Delaware corporation ("**Parent**", Parent together with Borrower and Holdings, each, a "**Credit Party**", and collectively, the "**Credit Parties**"), are party to that certain Trademark Security Agreement, dated as of September 22, 2010 (the "**Security Agreement**"), pursuant to which the Credit Parties granted a security interest to Agent in, and a collateral assignment to Agent of, among other things, the trademark registrations and trademark applications (and intellectual property relating to same) of the Credit Parties, including, without limitation, the trademark registrations and trademark applications (and intellectual property relating to same) set forth on Exhibit A hereto; and

WHEREAS, the Credit Parties have requested that Agent release its security interest in certain of the trademark registrations and trademark applications of the Credit Parties and reassign the same to the applicable Credit Party.

WHEREAS, Agent has agreed to terminate and release the entirety of its security interest in and to the Credit Parties' trademark registrations and trademark applications.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, Agent hereby states as follows:

1. Agent hereby terminates, cancels, re-pledges, reassigns and releases any and all security interests in all of the Credit Parties' right, title and interest in and to all of the following (the "**Trademark Collateral**"):

(a) the trademarks, trade names, corporate names, company names, business names, fictitious business names, trade dress, service marks, logos, other business identifiers, prints and labels on which any of the foregoing have appeared or appear, the registrations and recordings thereof, and applications in connection therewith, whether pending or in preparation for filing, including registrations, recordings and applications in the United States Patent and Trademark Office or in any office or agency of the United States of America or any State thereof or any foreign country, as set forth on Exhibit A hereto (each of the foregoing items in this clause (a) being called a "**Trademark**");

(b) the Trademark licenses, if any, referred to in Exhibit A hereto;

(c) all reissues, extensions or renewals of any of the items described in clauses (a) and (b);

(d) all of the goodwill of the business connected with the use of, and symbolized by the items described in clauses (a) and (b); and

(e) all proceeds of, and rights associated with, the foregoing, including any claim by any Credit Party against third parties for past, present or future infringement or dilution of any Trademark, Trademark registration, or Trademark license with respect to the Trademarks, Trademark registrations or Trademark licenses referred to in Exhibit A hereto, or for any injury to the goodwill associated with the use of a Trademark or for breach or enforcement of a Trademark license.

2. Agent hereby reassigns, grants and conveys to the applicable Credit Party, without any representation, recourse or undertaking by Agent, all of Agent's right, title and interest in and to the Trademark Collateral. If and to the extent Agent has acquired any right, title or interest to any of the Trademarks or the goodwill associated therewith, it hereby assigns and transfers such rights, title or interest to the applicable Credit Party.

3. Agent shall take all further actions, reasonably acceptable to Agent, and provide to the applicable Credit Party and each of its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), requested by such Credit Party, each at such Credit Party's sole cost and expense, to more fully and effectively effectuate the purposes of this Release.
