## **TRADEMARK ASSIGNMENT (U.S.)**



TCS hereby agrees to and does hereby sell, assign and transfer to INTELLITRANS, all of its rights, title and interest in and to the Trademark Rights, including the right to sue others for past acts of infringement of the Trademark Rights and to retain all revenues received from others for past acts of infringement of the Trademark Rights.

2. TCS further agrees for itself, its predecessors, successors, and assigns to execute, without further consideration, any further legal documents, any further assignments, and any releases, declarations, renewals or other applications for Trademark Rights that may

be deemed necessary by INTELLITRANS, or by INTELLITRANS' successors-in-interest or assigns, fully to secure to INTELLITRANS, or to INTELLITRANS' successors-in-interest or assigns, TCS's interest as aforesaid in and to the Trademark Rights.


