ASSIGNMENT OF MARK

This Assignment of Mark ("Assignment") dated effective as of Sept. 12, 2011 ("Effective Date") is made by and between PITTSBURGH PENGUINS LP, a Pennsylvania limited partnership (hereinafter "ASSIGNOR") and WBS Hockey LP, a Pennsylvania limited partnership (hereinafter "ASSIGNEE").

WHEREAS, ASSIGNOR desires to assign its rights in the mark "MISCELLANEOUS DESIGN (Muscular Penguin with Hockey Stick)" and in U.S. Registration No. 1,601,443 therefor as set forth on Exhibit 1 hereto (collectively the "Mark") to ASSIGNEE; and

ASSIGNOR hereby sells, assigns and transfers unto ASSIGNEE, and ASSIGNEE hereby accepts, ASSIGNOR's entire right, title and interest in and to the Mark, together with all goodwill associated therewith including, without limitation, all past, present and future registrations therefor and all past, present and future renewals and extensions of registrations, and all other corresponding rights that are or may be secured under the laws of the United States or any foreign country, now or hereafter in effect, and all income, royalties or payments due or payable after the Effective Date, all causes of action arising from any past, present or future infringement of the Mark and the right to sue for damages and other remedies with respect thereto, all for ASSIGNEE's own use and enjoyment and for the use and enjoyment of ASSIGNEE's successors, assigns and other legal representatives.


2. ASSIGNOR will use commercially reasonable efforts to execute any further lawful and proper documents and instruments which may be necessary to effect the intent of this Agreement.
