AFFIDAVIT OF OWNERSHIP

CompareNetworks, Inc. (formerly Biocompare, Inc.), by its Chief Financial Officer, Paul Gatti, declares under penalty of perjury as follows:

1. I am the Chief Financial Officer of CompareNetworks, Inc. I have personal knowledge of the facts set forth in the declaration and I am competent to so testify if called as a witness in this action.

2. CompareNetworks, Inc. is a Delaware corporation, with its principal office located at 395 Oyster Point Blvd., Suite 321, South San Francisco, CA 94080 and is entitled to the possession and is the legal and beneficial owner of U.S. Patent and Trademark Office ("USPTO") trademark registration number 2,608,948 (hereinafter referred to as the "Biocompare Mark"),

3. The application for the registration of the Biocompare Mark was originally filed by Biocompare, Inc., CompareNetworks, Inc.'s predecessor company, on November 8, 2000. Biocompare, Inc. then became the registered owner of the Biocompare Mark pursuant to the USPTO Registration of Certificate (no. 2,608,948), issuance on August 20, 2002.

4. CompareNetworks, Inc. filed a Change of Name assignment on or about August 19, 2008, with the USPTO Assignment Services Branch ("ASB") conveying the change of corporation's name from Biocompare, Inc. to CompareNetworks, Inc. The Change of Name assignment was recorded on August 19, 2008 by the ASB as reel and frame no: 3837/0993.


5. On or about August 10, 2011, CompareNetworks, Inc. learned that an erroneous conveyance assignment of the Biocompare Mark had been filed by Cleaning Technologies Group, LLC (the "Assignor") for the security interest benefit of Fifth Third Bank (the "Assignee"). The security interest conveyance in the Biocompare Mark was erroneously recorded by the ASB on October 4, 2006. The previous and erroneous recording in question is reel and frame no: 3402/0402 ("Erroneous Assignment").

6. CompareNetworks, Inc. asserts that the ownership of the Biocompare Mark should not be considered altered by the Erroneous Assignment and that CompareNetworks, Inc. is and continues to be the legal owner of the Biocompare Mark and that CompareNetworks, Inc. has not sold, assigned, pledged, transferred, licensed, deposited under any agreement, or hypothecated its ownership of the Biocompare Mark or any interest therein, or signed any power of attorney or other authorization respecting same which is now outstanding and in force, or otherwise disposed of the same; and no person, firm, corporation, agency or government other than CompareNetworks, Inc. has or has asserted any right, title, claim, equity or interest in, to or respecting the Biocompare Mark or the proceeds thereof.
