RELEASE OF SECURITY INTEREST IN
INTELLECTUAL PROPERTY

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Release") made as of November 1, 2011, is granted by BANK OF AMERICA, N.A., in its capacity as administrative agent pursuant to the Security Agreement (as defined below) (in such capacity, the "Administrative Agent") in favor of the parties listed in Exhibit A (the "Grantors").

WHEREAS, J.M. Huber Corporation (the "Borrower"), the other Grantors, the Administrative Agent, the lenders party thereto and the other parties party thereto have entered into that certain Credit Agreement dated as of August 30, 2006, as amended and restated as of February 22, 2011 (the "Credit Agreement");

WHEREAS, the Borrower, the Grantors and the Administrative Agent have entered into that certain Security Agreement dated as of February 22, 2011 (the "Security Agreement");

WHEREAS, the Administrative Agent and the Grantors have entered into that certain Intellectual Property Security Agreement, dated as of February 22, 2011 (the "Intellectual Property Security Agreement"; all capitalized terms used but not defined herein shall have the respective meanings ascribed thereto in the Intellectual Property Security Agreement);

WHEREAS, an executed copy of the Intellectual Property Security Agreement was recorded in the United States Patent and Trademark Office on March 29, 2011 at Reel 26042, Frame 0063 and at Reel 4510, Frame 0183;

WHEREAS, pursuant to the terms and conditions of the Intellectual Property Security Agreement, the Grantors granted to the Administrative Agent a security interest in all of their right, title and interest in and to the Collateral (collectively, the "Released IP"), including, without limitation, the Patent registrations and applications set forth on Schedule I hereto and the Trademark registrations and applications set forth on Schedule II hereto; and

WHEREAS, the Grantors have paid all of their outstanding indebtedness under the Credit Agreement which is secured by the Intellectual Property Security Agreement and have requested that the Administrative Agent release the security interest granted thereunder in the Released IP.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Administrative Agent hereby:

1. terminates the Intellectual Property Security Agreement, and hereby terminates, cancels and releases the security interest granted thereunder against the Released IP, without warranty or recourse;
2. agrees that any power of attorney or similar rights granted by any Grantor to the Administrative Agent pursuant to or in connection with the Intellectual Property Security Agreement is terminated; and

3. authorizes and requests that the United States Patent and Trademark Office note and record the existence of the release hereby given.

The Administrative Agent shall take all further actions, and provide to the Grantors and their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), at the sole cost and expense of the Grantors, reasonably requested by the Grantors to more fully and effectively effectuate the purposes of this Release.

This Release shall be construed in accordance with and governed by the laws of the State of New York.


