CONTRIBUTION AND ASSUMPTION AGREEMENT

- 3. <u>Further Actions</u>. Each of the parties hereto shall from time to time execute and deliver all such further documents and do all acts and things as any other party may reasonably require to effectively carry out or better evidence or perfect the full intent and meaning of this Agreement.
- 4. Effective Time. The transactions contemplated hereby shall be effective as of 4:051.... Eastern Daylight Time, on August 18, 2008 (the "Effective Time").
