**AFFIDAVIT OF ASSIGNMENT IMPROPERLY FILED AND RECORDED BY

1. I am over the age of eighteen and I am competent to testify to, and have personal knowledge of, the matters contained herein.

2. I am President of Some Guys & Truck, Inc., a Virginia corporation, having a principal place of business at 45726 ELMWOOD COURT, STERLING, VA 20166.

3. I am President of Brand Names, Inc., a Virginia corporation, having a principal place of business at 45726 ELMWOOD COURT, STERLING, VA 20166. Brand Names, Inc. is the sole member and manager of Moving Brands, LLC, a Virginia limited liability company, having a principal place of business at 45726 ELMWOOD COURT, STERLING, VA 20166.

4. I am President of Two Guys and a Truck, Inc., a Virginia corporation, having a principal place of business at 45726 ELMWOOD COURT, STERLING, VA 20166.

5. An Assignment of Trademarks was recorded in the United States Patent Trademark Office (USPTO) on February 24, 2011 at Reel 004485, Frame 0896. In this Assignment, Moving Names, LLC, David S. Underwood, 2GT, Inc. and Diamond Holdings, LP transferred ownership of Federal Registration Nos. 3,762,154; 3,776,769; 3,579,083; 3,579,084 to Some Guys & Truck, Inc. and Brand Names, Inc. There has been no subsequent transfer of the marks to any party.

6. Some Guys remains the correct owner of the Two Guys Marks, and the previously recorded document for assignment by Moving Names, as recorded at Reel: 004624/Frame: 0801 along with Moving Names' Affidavit of Default, were submitted with erroneous information.

7. The chain of title for the registrations identified should not be considered altered by the incorrect assignee or name change, and the last correct assignee has been and continues to be the owner of the registrations at issue.

8. A recording fee (as required by 37 C.F.R. §§2.6 and 3.41) for each registration to be corrected is being paid concurrently herewith.
