DEED OF ASSIGNMENT OF UNITED STATES AND CANADIAN TRADEMARKS

WHEREAS, Kraft Foods UK Ltd, a company organized and existing under the laws of England and Wales, and having its registered office at St. George's House, Bayshill Road, Cheltenham, Gloucestershire GL 50 3AE, United Kingdom ("Assignor"), has been using certain trademarks in conjunction with its business, including but not limited to the trademark and registrations and common law marks, set forth in Appendix A attached hereto (collectively, the "Trademarks"); and

WHEREAS, Kraft Foods UK Intellectual Property Limited, a company organized and existing under the laws of England and Wales and having its registered office at St. George's House, Bayshill Road, Cheltenham, Gloucestershire GL50 3AE , United Kingdom ("Assignee"), is desirous of acquiring the entire right, title and interest in and to the Trademarks, including the right to bring actions for infringement of the Trademarks occurring prior to the date of this Deed of Assignment.

NOW, THEREFORE, TO ALL WHOM IT MAY CONCERN, as agreed between the Assignor and the Assignee in the Deed of Contribution dated 20 April 2009, the Assignor has assigned, and transferred, and by these presents does assign, and transfer unto the Assignee, the Assignor's entire right, title and interest in and to the Trademarks used in conjunction with the Assignor's business, the appurtenant goodwill and the right to bring actions for infringements of the Trademarks occurring prior to the date of this Deed of Assignment.

The construction, validity and performance of this Deed of Assignment and all non-contractual obligations arising from or connected with this Deed of Assignment shall be

governed by the laws of England. This Deed of Assignment shall become effective as of April 20, 2009.

IN WITNESS WHEREOF, the Assignee and Assignor have caused this Deed of Assignment of Canada and United States Trademarks to be executed as a Deed by their authorized representative and is delivered on the date first written below.

DEED OF CONTRIBUTION

THIS DEED is made on the 20th day of April 2009

BETWEEN:

- (1) **KRAFT FOODS UK LTD.** a company incorporated under the laws of England with registered number 00203663 and having its registered office at St. George's House, Bayshill Road, Cheltenham GL50 3AE ("**KF UK**"); and
- (2) **KRAFT FOODS UK INTELLECTUAL PROPERTY LIMITED** a company incorporated under the laws of England with registered number 06745218 and having its registered office at St. George's House, Bayshill Road, Cheltenham GL50 3AE ("**KFUK IP**").

RECITALS:

- (A) KF UK is the legal and/ or beneficial owner of certain registered and unregistered intellectual property rights as set out in the Schedules to this Deed;
- (B) KF UK has agreed with KFUK IP to make a contribution of the registered and unregistered intellectual property rights listed in the Schedules to this Deed to KFUK IP, and KFUK IP has agreed to accept the contribution of these rights; and
- (C) KF UK is the parent company of KFUK IP.

IT IS AGREED as follows:

1. DEFINITIONS AND INTERPRETATION

- 1.1 "**Effective Date**" shall mean 20 April 2009.
- 1.2 "**Intellectual Property**" shall mean the registered and unregistered intellectual property rights listed in the Schedules to this Deed.
- 1.3 References to this Deed include the recitals and Schedules which form part of this Deed for all purposes. References in this Deed to the parties, the recitals, Schedules and clauses are references respectively to the parties and their legal personal representatives, successors and permitted assigns, the recitals and Schedules to and clauses of this Deed.
- 1.4 The headings in this Deed are for convenience of reference only and shall not affect the interpretation of this Deed.

2. CONTRIBUTION OF THE INTELLECTUAL PROPERTY

- 2.1 With effect from the Effective Date and subject to the terms of this Deed, KF UK shall contribute to KFUK IP and KFUK IP shall accept, the Intellectual Property, together with all rights now or hereafter attaching to it.

3. COMPLETION/DELIVERABLES

As soon as reasonably practicable following the execution of this Deed, KF UK shall provide to KFUK IP duly executed assignments (in the agreed form) together with all such other documents, including such waivers or consents, as KFUK IP may require to vest legal and/ or beneficial title in the Intellectual Property in KFUK IP, including, but not limited to, enabling KFUK IP to be registered as the legal owner of the same.

4. TRANSFER OF OWNERSHIP AND FURTHER ASSURANCES

- 4.1 With effect from the Effective Date, KFUK IP shall be the beneficial and economic owner of the Intellectual Property as listed in Schedule A and, in relation to any Intellectual Property the legal title to which has not been transferred at the Effective Date, KF UK shall hold all such Intellectual Property as nominee for the benefit of KFUK IP until legal title has been formally transferred.
- 4.2 With effect from the Effective Date, KFUK IP shall be the legal title owner of the Intellectual Property as listed in Schedule B and, in relation to any such Intellectual Property the legal title to which has not been transferred at the Effective Date, KF UK shall hold all such Intellectual Property as nominee of KFUK IP until legal title has been formally transferred. For the avoidance of doubt, KF UK shall not transfer and KFUK IP shall not acquire any economic or beneficial interest in any Intellectual Property listed in Schedule B.
- 4.3 KF UK agrees (at its own cost) to perform (or procure the performance of) all further acts and things, and execute and deliver (or procure the execution and delivery of) such further documents, as may be required by law or as KFUK IP may reasonably require, whether on or after the Effective Date, to implement and/or give effect to this Deed and the transactions contemplated by this Deed and for the purpose of vesting in KFUK IP the full legal and beneficial ownership of the Intellectual Property listed in Schedule A and the full legal ownership of the Intellectual Property listed in Schedule B.
- 4.4 To the extent that the transfer of registered ownership of the Intellectual Property to KFUK IP is not perfected on the Effective Date or would be contrary to applicable law, the parties will use their best efforts to provide to, or cause to be provided to, KFUK IP, to the extent permitted by law, the rights and benefits associated with the registered ownership of the Intellectual Property and take such other actions as may reasonably be requested by KFUK IP in order to place KFUK IP, insofar as reasonably possible, in the same position as if KFUK IP were the registered owner of the Intellectual Property.
- 4.5 KFUK IP will pay, perform and discharge on behalf of KF UK all of KF UK's obligations with respect to the Intellectual Property, in each case accruing on or after the Effective Date. In the event that KF UK holds the Intellectual Property for KFUK IP as nominee, KFUK IP irrevocably and unconditionally undertakes with KF UK to indemnify KF UK immediately on demand against any and all liabilities, losses, penalties, fines, damages, claims, costs, expenses and legal and professional fees and disbursements incurred, suffered or sustained by KF UK or asserted against KF UK in connection with KF UK holding the Intellectual Property as nominee for KFUK IP.

5. GENERAL

- 5.1 Neither party shall assign or transfer its rights or obligations under this Deed except with the prior written approval of the other party; provided, however, that both parties may assign or transfer its rights or obligations under this Deed to any member of the group of companies of which it forms part.
- 5.2 Save as expressly provided herein, a person who is not a party to this Deed has no right under the Contracts (Rights of Third Parties) Act 1999 to enforce any term of this Deed but this does not affect any right or remedy of a third party which exists or is available apart from that Act.
- 5.3 The parties hereto shall each perform such acts, execute and deliver such instruments and documents, and do all such other things as may be reasonably necessary to complete the transactions contemplated in this Deed.

- 5.4 This Deed (together with any documents executed pursuant hereto) constitutes the whole agreement between the parties to this Deed.
- 5.5 All of the provisions of this Deed shall remain in full force and effect notwithstanding completion (except insofar as they set out obligations which have been fully performed at completion).
- 5.6 This Deed may be executed in one or more counterparts, and by the parties on separate counterparts, but shall not be effective until each party has executed at least one counterpart and each such counterpart shall constitute an original of this Deed but all the counterparts shall together constitute one and the same instrument.
- 5.7 No variation (or waiver of any provision or condition of this Deed) shall be effective unless it is in writing and signed by or on behalf of each of the parties (or, in the case of a waiver, by or on behalf of the party waiving compliance).
- 5.8 The construction, validity and performance of this Deed and all non-contractual obligations arising from or connected with this Deed shall be governed by the laws of England.
- 5.9 Each party irrevocably agrees to submit to the exclusive jurisdiction of the courts of England over any claim or matter arising under or in connection with this Deed and that accordingly any proceedings in respect of any such claim or matter may be brought in such court. Nothing in this clause shall limit the right of KFUK IP to take proceedings against any other party in any other court of competent jurisdiction, nor shall the taking of proceedings in any one or more jurisdictions preclude the taking of proceedings in any other jurisdictions, whether concurrently or not, to the extent permitted by the law of such other jurisdiction.

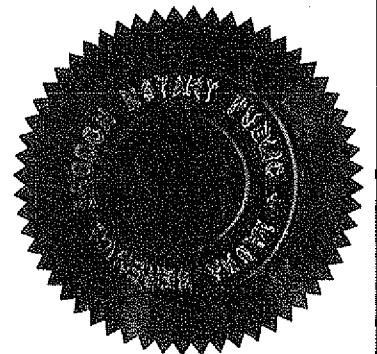
