RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST ("Release") is made effective as of October 28, 2011 by JPMORGAN CHASE BANK, NATIONAL ASSOCIATION, (the "Administrative Agent") to TRAVELWEB LLC, (the "Grantor"), as follows:

WHEREAS, on September 25, 2007, priceline.com Incorporated (the "Borrower"), the Grantor, certain other Subsidiaries of the Borrower and the Administrative Agent entered into a Pledge and Security Agreement (the "Security Agreement") and the Grantor and the Administrative Agent entered into a Confirmatory Grant of Security Interest in United States Trademarks (the "Confirmatory Grant");

WHEREAS, pursuant to said Security Agreement and Confirmatory Grant, the Grantor granted to the Administrative Agent on behalf of the Lenders, among other collateral, a continuing security interest in all of the Grantor's right, title and interest, including goodwill, in, to and under the United States Trademarks listed on the attached Schedule A (the "Marks");

WHEREAS, said Confirmatory Grant was recorded in the United States Patent & Trademark Office on September 26, 2007 at reel/frame 003628/0352; and

WHEREAS, the Administrative Agent wishes to release its security interest in the Marks.

NOW THEREFORE, as the Grantor has satisfied its obligations under said Security Agreement and Confirmatory Grant, the Administrative Agent hereby terminates, releases and discharges any security interest in and lien upon the Marks, and assigns, transfers, and conveys to Grantor any and all right, title or interest in, or to, the Marks that the Administrative Agent may hold.
