

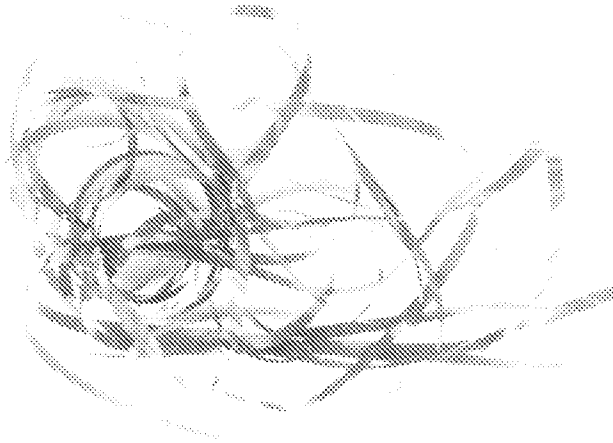

FROM THE FLIP SIDE

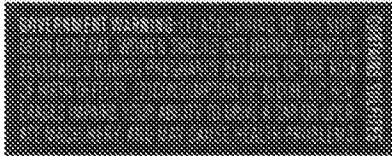




B SIDE
