RELEASE OF TRADEMARK SECURITY AGREEMENTS

This Release of Trademark Security Agreements (this "Release") is made as of April 27, 2010 (the "Effective Date"), by Silver Point Finance, LLC, as agent for the lenders (in such capacity, the "Agent"), in favor of International Wire Group, Inc. ("International Wire"), Omega Wire, Inc. fka Camden Wire Co., Inc. ("Omega"), and IWG High Performance Conductors, Inc. ("HPC," and collectively with International Wire and Omega, the "Grantors").

WHEREAS, pursuant to the terms and conditions of the Trademark Collateral Assignment and Security Agreement dated October 20, 2004, between International Wire and the Agent, the Trademark Collateral Assignment and Security Agreement dated October 20, 2004, between Omega and the Agent, and the Trademark Collateral Assignment and Security Agreement dated March 31, 2006, between HPC and the Agent (collectively the "Trademark Security Agreements"), the Grantors granted to the Agent a continuing security interest in all of their right, title, and interest in and to certain collateral including the trademark registrations set forth on Schedule 1 hereto, along with the goodwill associated therewith (the "Trademark Collateral");

WHEREAS, the Trademark Security Agreements were recorded with the United States Patent and Trademark Office on February 27, 2006, on Reel/Frame 3254/0350 and 3254/375, and on June 14, 2006, on Reel/Frame 3326/0968; and

WHEREAS, the Agent therefore desires to release terminate, discharge, and convey its security interest in and to the Trademark Collateral and grant all of its right, title, and interest in the Trademark Collateral to Grantors;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:

1. The Agent hereby terminates the Trademark Security Agreements and releases, terminates, discharges, reassigns, and conveys to Grantors any and all security interests in, and any other right, title, or interest of any kind or nature in, to, or under the Trademark Collateral, including without limitation the trademark registrations listed on Schedule 1 attached hereto.

2. The Agent hereby authorizes and acknowledges the termination of the Trademark Security Agreements. At Grantors' expense, the Agent hereby agrees to duly execute, acknowledge, procure, and deliver any further documents and to do such other acts as may be reasonably necessary to affect the release of the security interest contemplated hereby and terminate the Trademark Security Agreements.

3. This Release shall be governed by, and construed in accordance with, the laws of the State of New York, without reference to its choice of law rules that would result in the application of the laws of another jurisdiction.
