

which are hereby acknowledged, ASSIGNOR hereby assigns, conveys, bequeaths, sells and transfers to ASSIGNEE any and all right, title and interest held by ASSIGNOR, throughout the world, in and to the Marks, together with any and all goodwill of the business appurtenant to and symbolized by the Marks, and including without limitation any and all registrations, applications for registration, Internet domain names (including without limitation those listed in Schedule "A" hereto) and common law rights related thereto, and the right to sue and recover for, and the right to profits or damages due or accrued arising out of or in connection with, any and all past, present or future infringements or dilution of or damage or injury to the Marks, to be held and enjoyed by ASSIGNEE, its successors and assigns, to the same extent that such would have been held and enjoyed by ASSIGNOR had such assignment not been made. ASSIGNOR shall execute and deliver to ASSIGNEE such further documents, and shall perform such further acts, as are requested by ASSIGNEE to confirm, effectuate, implement, memorialize, execute and carry out the terms of this Assignment, or to assist ASSIGNEE in the registration, recordation, protection, enforcement, defense or exploitation of the Marks.
