ASSIGNMENT OF TRADEMARK

Now therefore, for good and valuable consideration, the receipt of which is hereby acknowledged, Assignor hereby grants, assigns, conveys and transfers unto said Assignee the entire right, title and interest in said Trademark Rights as a successor to the ongoing and existing portion of Assignor's business to which mark pertains, free and clear of all encumbrances, including the right to bring any action for prior acts of infringement.

Assignor agrees to cooperate with said Assignee and to execute without additional consideration any additional instruments or documents as reasonably requested by Assignee for Assignee or its designee to register or fully effect the transfer and assignment of the Trademark Rights.


