

AND, ASSIGNOR HEREBY covenants that Assignor has the full right to convey the interest assigned by this Assignment, and Assignor has not executed and will not execute any agreement in conflict with this Assignment;

AND, ASSIGNOR HEREBY further covenants and agrees that Assignor will, without further consideration, communicate with Assignee, its successors and assigns, any facts known to Assignor respecting that trademark and that registration, and testify in any legal proceeding, sign all lawful papers when called upon to do so, execute and deliver any and all papers that may be necessary or desirable to perfect the title to that trademark and that registration in said Assignee, its successors or assigns, make all rightful oaths and generally do everything possible to aid Assignee, its successors and assigns, to obtain and enforce proper trademark protection in connection with that trademark and that registration in the United States and any foreign country, it being understood that any reasonable expense incident to the execution of such papers shall be borne by the Assignee, its successors and assigns.
