**TRADEMARK RELEASE AND REASSIGNMENT**

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of November 8, 2011 by THE PRIVATEBANK AND TRUST COMPANY (“**Bank**”).

WITNESSETH:

WHEREAS, Bank and PACE AMERICAN ENTERPRISES, INC., a Delaware corporation (“**Grantor**”), were parties to that certain Short Form Trademark Security Agreement dated as of June 25, 2010 (the “**Security Agreement**”), pursuant to which Grantor granted a security interest to Bank in certain trademarks and trademark licenses (the “**Secured Trademarks**”) as security for certain obligations owing by Grantor to Bank, including the Secured Trademarks set forth on Schedule 1 hereto; and

WHEREAS, the Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on July 2, 2010, at Reel 4236, Frame 0678; and

WHEREAS, Grantor has requested that Bank release its security interest in and lien on all of Grantor’s right, title and interest in, to and under the Secured Trademarks and reassign the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Bank hereby releases its security interest in and lien on all of Grantor’s right, title and interest in, to and under the following Secured Trademarks:

a. each Trademark listed on Schedule A annexed hereto, together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each such Trademark; and

b. all products and proceeds of the foregoing, including without limitation, any claim by Grantor against third parties for past, present or future (a) infringement or dilution of each such Trademark, or (b) injury to the goodwill associated with each such Trademark.

2. Bank hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Bank, all of Bank’s right, title and interest in and to the Secured Trademarks.
