


**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto hereby agree as follows:

1. Assignors hereby sell, transfer, assign, and deliver to the Assignee all of Assignors' right, title, and interest in, to and under the Marks, together with the goodwill associated therewith; including all applications and registrations therefor. Assignors further sell, transfer, assign, and deliver to Assignee, any and all causes of action arising under the rights assigned hereunder that may have arisen prior to the date that this Agreement was executed. Assignors further sell, transfer, assign, and deliver to Assignee all proceeds to infringement suits, the right to sue for past, present and future infringements, and all rights corresponding thereto throughout the world for all of the rights herein assigned.
2. Assignors agree to execute and deliver at a future date any additional documents that Assignee reasonably determines are required under federal or state law, to perfect Assignee's ownership of any intellectual property rights in the Marks. Assignors will not file any applications for trademark registration in the U.S. Patent and Trademark Office or its foreign counterparts for the Marks.
