## SUMMARY ARTICLES OF MERGER

Pursuant to the provisions of the Missouri General and Business Corporation Law, the undersigned entities hereby certify the following:

1. That Baldor Electric Company, a Missouri corporation, (the "Surviving Corporation") and Reliance Electric Company, a Delaware corporation, (the "Merging Corporation" and, together with Surviving Corporation, the "Constituent Corporations") are hereby merged and that the Surviving Corporation is the surviving entity.
2. An Agreement and Plan of Merger ("Plan of Merger") was authorized and approved by the Board of Directors of each of Merging Company and Surviving Company in accordance with R.S. Mo. Chapter 351.
3. The name of the corporation surviving the merger is "Baldor Electric Company."

Box 2400, Fort Smith, AR, 72901, a copy of which will be furnished by Surviving Corporation, on request and without cost, to any shareholder of any of the Constituent Corporations.
7. The effective date of the merger shall be upon the filing of these Articles of Merger by the Missouri Secretary of State.



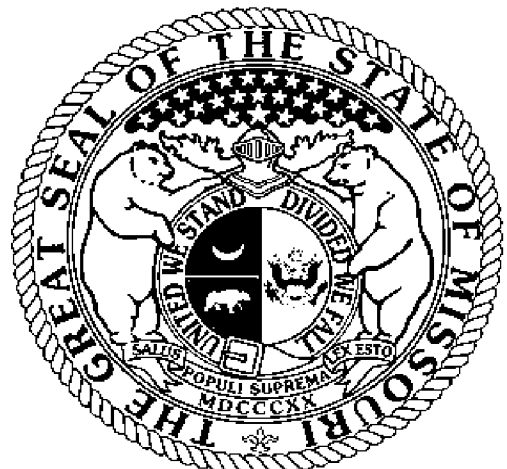
