2. MISCELLANEOUS


(a) Assignor authorizes the Commissioner of Patents and Trademarks of the United States to record the Application and any resulting registration, and title thereto, as the property of Assignee, its successors, legal representatives and assigns in accordance with the terms of this Assignment.
