## RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

This Release of Intellectual Property Security Agreement dated as of November 10, 2011 (the "**Release of Intellectual Property Security Agreement**"), is made by LBC CREDIT PARTNERS II, L.P., as Agent (in such capacity, "**Agent**").

### WITNESSETH:

WHEREAS, Agent, MCMC LLC ("**MCMC**"), MCMC HOLDINGS LLC ("**Holdings**"), COUNTRY-WIDE INDEPENDENT EXAMS, LLC ("**CW**"), MBA HOLDCO, LLC ("**MBA**") and LITIGATION SOLUTIONS, LLC ("**LS**"; LS, MCMC, Holdings, CW and MBA, collectively, the "**Grantors**"), are parties to that certain Intellectual Property Security Agreement, dated as of June 30, 2010 (the "**Assignment**"), pursuant to which Grantors granted a security interest to Agent in certain Patent, Trademark and Copyright Collateral (as defined below) as security for certain obligations owing by Grantors to Agent, including the Patents set forth on Schedule I, the Trademarks set forth on Schedule II and the Copyrights set forth on Schedule III hereto; and

WHEREAS, the Assignment was recorded by the Trademark Division of the United States Patent and Trademark Office on July 1, 2010 at Reel 4235, Frame 0527;

WHEREAS, the Assignment was recorded by the Copyright Division of the United States Library of Congress on February 16, 2011 at Volume 3592, Document 899; and

WHEREAS, Grantors have requested that Agent release its security interest in the Patents, Trademark and Copyright Collateral and reassign the same to Grantors.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases its security interest in all of Grantors' right, title and interest in and to the following (collectively the "**Patent, Trademark and Copyright Collateral**"):

(a) each Patent listed on Schedule I annexed hereto, together with any reissuances, continuations, continuations-in-part, revisions, extensions and reexaminations thereof;

(b) all products and proceeds of the foregoing, including without limitation, any claim by Grantors against third parties for past, present or future infringement of any Patent;

(c) each Trademark listed on Schedule II annexed hereto, together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark;

(d) all products and proceeds of the forgoing, including without limitation, any claim by Grantors against third parties for past, present or future (i) infringement or dilution of any Trademark;

(e) each Copyright listed on Schedule III annexed hereto, together with any reissues, continuations or extensions thereof; and

(f) all products and proceeds of the foregoing, including without limitation, any claim by Grantors against third parties for past, present or future infringement or dilution of any Copyright.

2. Agent hereby reassigns, grants and conveys to Grantors, without any representation, recourse or undertaking by Agent, all of Agent's right, title and interest in and to the Patent, Trademark and Copyright Collateral.

3. Notwithstanding anything contained herein to the contrary, this Release of Intellectual Property Security Agreement only applies to that certain Intellectual Property Security Agreement dated as of June 30, 2010 and recorded by (i) the Trademark Division of the United States Patent and Trademark Office on July 1, 2010 at Reel 4235, Frame 0527 and (ii) the Copyright Division of the United States Library of Congress on February 16, 2011 at Volume 3592, Document 899. Any other security interests or recordings in favor of Agent remain in full force and effect.
