# RELEASE OF SECURITY INTEREST IN U.S. TRADEMARKS

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

- 1. The Agent hereby releases, relinquishes, terminates and discharges in its entirety any and all Lien or security interest it has in the Trademarks. All rights, title and interest in and to such Trademarks, including, without limitation, the right to sue for past, present and future infringement, hereby reverts to the Borrower.
- 2. The Agent authorizes and requests the United States Patent and Trademark Office to record this Release against such Trademarks, as applicable.
- 3. The Agent hereby agrees to execute, acknowledge and deliver all such further instruments and to take all such further actions as may be reasonably requested or are required in order to more fully and effectively carry out the purpose of this Release.
