**FIRST AMENDED AND RESTATED
GRANT OF SECURITY INTEREST IN TRADEMARKS
(Wente Bros.)**

This FIRST AMENDED AND RESTATED GRANT OF SECURITY INTEREST IN TRADEMARKS, dated as of September 26, 2011 (this "Agreement"), is between WENTE BROS., a California corporation ("Pledgor"), with its principal place of business located at 5565 Tesla Road, Livermore, California 94550, and COMERICA BANK ("Bank"), with an office at 39200 Six Mile Road, MC 7512, Livonia, Michigan 48152, and amends and restates that certain Grant of Security Interest in Trademarks, dated as of October 30, 2007, from Pledgor to Bank.

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Pledgor hereby grants to Bank a security interest in the following:

(a) All of Pledgor's right, title and interest in and to the trademarks set forth in Attachment A hereto, applications to register and registrations of the same and like protections, and the entire goodwill of the business of Pledgor connected with and symbolized by such trademarks (collectively referred to as "Trademarks");

(b) Any and all claims for damages by way of past, present and future infringement of any of the rights included above, with the right, but not the obligation, to sue for and collect such damages for said use or infringement of the intellectual property rights set forth above;

(c) All licenses or other rights to use of the Trademarks, and all license fees and royalties arising from such use to the extent permitted by such license or rights;

(d) All amendments, renewals and extensions of any of the Trademarks; and

(e) All proceeds and products of the foregoing, including without limitation, all payments under insurance or any indemnity or warranty payable in respect of any of the foregoing.

This Agreement is made to secure prompt payment of any and all Indebtedness and in order to secure prompt performance by Pledgor of each of its covenants and duties under the Amended and Restated Loan and Security Agreement, dated September 1, 2006, between Pledgor and Bank (as it has been or as it may hereafter be amended, modified, supplemented, or restated, the "Loan and Security Agreement") and other obligations owing by Pledgor to Bank. This Agreement has been granted in conjunction with the security interest granted to Bank in the Loan and Security Agreement, in the Intellectual Property Security Agreement, dated March 7, 2003, between Pledgor and Bank (as it has been or as it may hereafter be amended, modified, supplemented, or restated, the "Intellectual Property Security Agreement"), and the Security Agreement, dated as of March 26, 2007, executed by Pledgor for the benefit of Bank (as it has been or as it may hereafter be amended, modified, supplemented or restated, the "Security Agreement"). The rights and remedies of Bank with respect to the security interest granted herein, and the obligations of Pledgor, are without prejudice to, and are in addition to, those set forth in the Loan and Security Agreement, the Intellectual Property Security Agreement, and the Security Agreement, all terms and provisions of which are incorporated herein by reference.

Capitalized terms not defined herein shall have the meanings ascribed to them in the Loan and Security Agreement. In the event that any provisions of this Agreement conflict with the Loan and Security Agreement, the Intellectual Property Security Agreement or the Security Agreement, the provisions of the Loan and Security Agreement, the Intellectual Property Security Agreement, or the Security Agreement, as applicable, shall govern.




