RECITALS:


- A. On 21 March 2005, IBI filed a trademark application for INQUIRY. On 5 September 2006, said application registered as United States Reg. no. 3,139,673 (the '673 registration).
- B. Assignor has adopted and has used the INQUIRY trademark in its business.
