**CONFIRMATORY GRANT OF SECURITY INTEREST  
IN TRADEMARKS**

THIS CONFIRMATORY GRANT OF SECURITY INTEREST IN TRADEMARKS (the "Confirmatory Grant") is made effective as of November 14, 2011, by and from each of the Persons listed on the signature page hereof (each, a "Grantor"), to and in favor of U.S. BANK NATIONAL ASSOCIATION, a national banking association, as administrative agent for the lenders (the "Lenders") from time to time party to the Credit Agreement defined below (in such capacity, the "Grantee").

WHEREAS, Handi Quilter Acquisition Company, a Delaware corporation (to be merged with and into Handi Quilter, Inc.), (the "Borrower"), the Lenders and the Grantee have entered into a Credit Agreement dated concurrently herewith (as may be amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement");

WHEREAS, the Borrower, certain affiliates of the Borrower and the Grantee have entered into a Pledge and Security Agreement dated concurrently herewith (as may be amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement");

WHEREAS, each applicable Grantor owns the trademarks listed on Exhibit A attached hereto (the "Trademarks"), which Trademarks are registered or applied for with the United States Patent and Trademark Office; and

WHEREAS, this Confirmatory Grant has been granted in conjunction with the security interest granted to Grantee under the Security Agreement. The rights and remedies of Grantee with respect to the security interest granted herein are without prejudice to and are in addition to those set forth in the Security Agreement and the other Loan Documents, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Confirmatory Grant are deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall govern.

NOW, THEREFORE, in consideration of the mutual covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, it is hereby agreed that:

1) Definitions. All capitalized terms not defined herein shall have the respective meaning given to them in the Credit Agreement.


2) The Security Interest.

(a) This Confirmatory Grant is made to secure the satisfactory performance and payment of (i) all the Obligations and (ii) all of the obligations and liabilities of the Guarantors under the Guaranty. Upon the payment in full of all Obligations (other than contingent indemnification obligations), Grantee shall promptly, upon such satisfaction, execute, acknowledge, and deliver to each Grantor (at such Grantor's expense) all reasonably requested instruments releasing the security interest in the Trademarks granted under this Confirmatory Grant.


(b) Each Grantor hereby grants to Grantee a security interest in all of the Trademarks now owned or from time to time after the date hereof owned or acquired by such Grantor.

IN WITNESS WHEREOF, each Grantor has executed this Confirmatory Grant of Security Interest effective as of the date first written above.




