MEMORANDUM OF RELEASE OF SECURITY INTEREST


This Memorandum of Release of Security Interest ("Memorandum") is given by Laurus Master Fund, Ltd. (In Liquidation) ("Laurus"), a Cayman Islands company having a mailing address of c/o Laurus Capital Management LLC, 825 Third Avenue, New York, NY 10022.

1. Tidel Engineering, L.P. f/k/a Sentinel Operating, L.P., a Texas limited partnership, together with Sentinel Technologies, Inc., a Delaware corporation, LLG, LLC, a Colorado limited liability company, Sentinel Cash Systems, LLC, a Delaware limited liability company, and Sentinel Management, LLC, a Delaware limited liability company (collectively, the "Debtors"), granted Laurus a security interest in the trademarks listed in Exhibit A attached hereto. The security interest was recorded with the United States Patent and Trademark Office on October 6, 2006. Pursuant to the Payoff Letter from LV Administrative Services, Inc. ("LV") and certain investors for whom LV acts as administrative and collateral agent (collectively, the "Creditor Parties"), to the Debtors dated October __, 2011, the Creditor Parties released and discharged this security interest in its entirety.
2. This Memorandum is being delivered by Laurus for the purpose of recording the release of the security interest with the United States Patent and Trademark Office and to provide third parties notice of the rights of Tidel Engineering, L.P. in the trademarks listed in Exhibit A. For confidentiality reasons, Laurus does not wish to record the above-referenced Payoff Letter.
