ASSIGNMENT OF INTELLECTUAL PROPERTY

WHEREAS, Kowa Pharmaceuticals America, Inc. (hereinafter referred to as "Kowa") was the original owner of the common law and statutory rights to the trademarks "DURABAC" and "FOLTRATE" including the federal registrations thereof (registration numbers 2,992,965 and 3,029,835) (hereinafter collectively referred to as "the Trademarks");

WHEREAS, Kowa and Poly Pharmaceuticals, Inc., an Alabama corporation (hereinafter referred to as "Poly"), intended that Poly acquire the entire interest of Kowa in and to the Trademarks as part of a transaction that occurred on October 31, 2008 (the "Transaction Date");


WHEREAS, Kowa and Poly now desire to evidence Poly's acquisition of Kowa's entire interests in and to the Trademarks as of the Transaction Date;

Now, therefore, for ten dollars (\$10) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, effective as of the Transaction Date, Kowa does hereby sell, assign, convey and transfer to Poly all of Kowa's right, title and interest in and to the DURABAC and FOLTRATE trademarks (including federal registration numbers 2,992,965 and 3,029,835), together with the goodwill of the businesses symbolized by the Trademarks and common law rights thereto, the same to be held and enjoyed by Poly, for its own use and benefit and that of its successors, assigns and legal representatives, together with all claims for damages by reason of past infringement, with the right to sue for and collect the same for its own use and for the use of its successors, assigns or other legal representatives.

Kowa does hereby covenant and agree to execute and deliver such other and further instruments and take such other and further actions as may be necessary or appropriate to transfer to Poly any and all interest in and to the Trademarks.
