AFFIDAVIT AND DECLARATION OF MARILYN MIGLIN, L.P.

Marlena Miglin, as President of Marilyn Miglin, Inc., the general partner of Marilyn Miglin, L.P., an Illinois limited partnership, hereby states as follows:

1. Marilyn Miglin, L.P. owns U.S. Registration No.. 1,175,709 for the trademark Marilyn Miglin & Design registered November 3, 1981 (the "Trademark").
2. An erroneous document was filed with the Assignment Branch of the Trademark Office incorrectly conveying the above Trademark to another entity. In particular, the incorrectly recorded documents are as follows:
 - a. An assignment from Ace, Inc. to Chicago First National Bank recorded at Reel/Frame 2759/0836; and
 - b. A document re-recorded to correct the assignors name as AEC, Inc. to First National Bank of Chicago recorded at Reel/Frame 2763/0682.
3. Neither of the conveyances identified in the previous paragraph are correct and, there never was a conveyance of the Trademark to ACE, Inc. or AEC, Inc. from the true owner, Marilyn Miglin, L.P.
4. Accordingly it is requested that the true owner and chain of title should reflect Marilyn Miglin, L.P. as the true owner of the Trademark and the Assignments indicated in the records of the Trademark Office at Trademark Assignment Abstract of Title, namely, Assignment: 3 and Assignment: 4 should be disregarded and have no effect on the chain of title.
5. The last correct Assignee, namely Marilyn Miglin, L.P., has been and continues to be the owner of the Trademark at issue.
