## TRADEMARK RELEASE

THIS TRADEMARK RELEASE is made as of November 17, 2011, by GE BUSINESS FINANCIAL SERVICES INC., formerly known as Merrill Lynch Business Financial Services Inc., as Agent ("Agent"). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Agreements (as defined below).

### WITNESSETH:

WHEREAS, MCALISTER'S CORPORATION, a Mississippi corporation ("Grantor") and Agent are parties to a Borrower Security Agreement dated as of August 1, 2005 and a Trademark Security Agreement dated as of August 1, 2005 (each, as amended, restated, supplemented or otherwise modified from time to time, an "Agreement", and collectively, the "Agreements"), pursuant to which Grantor granted a security interest to Agent in certain trademark collateral ("Collateral") as security for certain obligations owing by Grantor to Agent, including the trademarks set forth on Schedule 1 hereto; and

WHEREAS, Grantor has requested that Agent release its security interest in the Collateral.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

Agent hereby unconditionally and expressly releases, terminates and extinguishes any and all of its right, title and interest in and to any and all liens, security interests and rights in the Collateral which were established under and pursuant to the Agreements including, but not limited to, the trademarks listed on Schedule 1 annexed hereto and all of the goodwill of the business associated with the use of, and symbolized by, each such trademark; and all products and proceeds of the foregoing, including without limitation, any claims by Grantor against third parties for past, present or future (a) infringement or dilution of any trademark, or (b) injury to the goodwill associated with any trademark.
