**AFFIDAVIT REGARDING CORRECTION OF STATE OF
INCORPORATION OF REGISTRANT**

I, Jeffrey Torf, hereby declare under penalty of perjury pursuant to the provisions of 28 U.S.C. § 1746(2) that the statements set forth below are true and correct to the best of my knowledge.

1. I am Deputy General Counsel and Asst. Secy. of A.M. Castle & Co., a corporation organized under the laws of Maryland, having a business address at 1420 Kensington Road, Suite 220, Oak Brook, IL 60523 ("Castle").

2. On June 7, 1984, Castle filed Application Serial No. 73/484,080 (the "Application") in the U.S. Patent and Trademark Office, which application matured into U.S. Registration No. 1,336,058. In the application, Castle identified itself as "an Illinois Corporation." This state of incorporation for identifying Castle was a misnomer, as the correct state of incorporation is Maryland. The error of identifying Castle's state of incorporation as Illinois rather than Maryland was made in good faith. At the time of the filing of the Application, there was no legal entity existing under the name A.M. Castle & Co. which was incorporated in Illinois.

3. This affidavit is submitted to be recorded in the title records relating to U.S. Registration No. 1,336,058 for the purpose of clarifying the owner's state of incorporation for that registration, so that the title records will accurately reflect the owner's correct state of incorporation.
