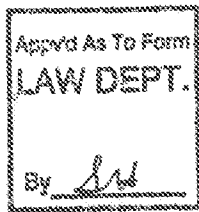
WHEREAS, ASSIGNEE is desirous of acquiring the Marks, together with the goodwill of the business associated with the Marks;
