As long as Assignee bears all costs of transferring the Trademarks to Assignee, including recording such change in ownership with the appropriate trademark office (e.g. the United States Patent and Trademark Office), Assignor agrees to execute and deliver at the request of the Assignee, all papers, instruments, and assignments, and to perform, as set forth in the Settlement Agreement, any other reasonable acts the Assignee may require in order to vest all Assignor's rights, title, and interest in and to the Trademarks to the Assignee and/or provide evidence to support any of the foregoing in the event such evidence is necessary to effectuate the assignment, to the extent such evidence is in the possession or control of Assignor.

Assignor agrees that the change of ownership be recorded in the United States Patent and Trademark Office, the official Trademark Register or any other applicable trademark register or office world-wide.




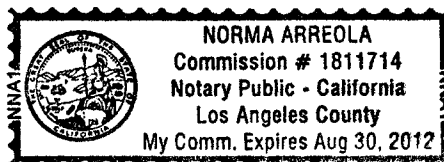
