1. Effective April 24, 1997, **The First National Bank of Boston**, Boston, Massachusetts, Charter Number 200, changed its name to **BankBoston, National Association**, also legally referred to as **BankBoston, N.A.**
2. Effective March 1, 2000, **Fleet National Bank**, Providence, Rhode Island, Charter Number 1338, merged into and under the charter of **BankBoston, N.A.**, Boston, Massachusetts, Charter Number 200, with the resulting Bank adopting the title of **Fleet National Bank**, with its head office located in Providence, Rhode Island.
3. Effective June 13, 2005, **Fleet National Bank**, Providence, Rhode Island, Charter Number 200, was merged into and under the charter and title of **Bank of America, National Association**, Charlotte, North Carolina, Charter Number 13044.
