This Termination and Release of Trademark Security Agreement (this "Release") is dated as of June 29, 2010, by and between **WELLS FARGO BANK, NATIONAL ASSOCIATION** ("Lender") and **WILD MARKS, INC.**, a Nevada corporation ("Grantor").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender and Grantor hereby agree as follows:

1. Release and Assignment. Lender hereby further evidences its termination and release of any and all security interests in and liens on the Trademarks, and Lender hereby assigns and transfers to the Grantor, without recourse, all of Lender's right, title and interest in and to each of the Trademarks and the related trademark applications, trademark registrations and goodwill, effective as of the date set forth above.

2. Acknowledgement. The Grantor hereby acknowledges and accepts the foregoing release and assignment by Lender.

3. Counterparts. This Release may be executed in any number of counterparts which shall together constitute one and the same agreement.
