

This letter is the official certification of the Office of the Comptroller of the Currency (OCC) to merge BLC Bank, National Association, Strasburg, Pennsylvania with and into PNC Bank, National Association, Pittsburgh, Pennsylvania, effective as of 11:59 P.M. on August 8, 2008. The resulting bank title is PNC Bank, National Association, and the charter number is 1316.

This is also the official authorization given to PNC Bank, National Association, to operate the branches of the target institution and the main office of the target institution as a branch. The newly authorized branch and its assigned OCC branch number is listed in Attachment A. Branches of a national bank target are not listed since they are automatically carried over to the resulting bank and retain their current OCC branch numbers.

If the combination does not occur as represented in your letter of July 25, 2008, this certification must be returned to the OCC.

Please be advised that the OCC is also authorizing the resulting bank, should the combination occur between Call Report dates, to recalculate its legal lending limit. The new lending limit should be calculated by using data from the last Call Report of the individual banks filed prior to consummating the merger, as adjusted for the combination. The resulting bank will then file a new Call Report and begin calculating its legal lending limit according to 12 C.F.R. §32.4(a) at the end of the quarter following consummation of the combination.
