

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lender does hereby release and relinquish, and does hereby reassign to the Pledgor, without representation or warranty, all of the Lender's right, title and interest in and to the Trademarks listed on the attached Schedule A, and the use thereof, together with all proceeds and products thereof and the goodwill of the businesses symbolized by the Trademarks, and does hereby agree that the filing of the Short-Form Security Agreement in the United States Patent and Trademark Office as aforesaid may be removed of record.
