TRADE MARK LICENSE AGREEMENT

This license agreement is made and entered on the 15th day of November, 2011, the effective date, between YUEN FOONG YU PAPER MFG. CO., LTD. (hereinafter called THE LICENSOR), located at NO. 14, JEOU TANG RD., DASHU DIST., KAOHSIUNG CITY, TAIWAN. R.O.C., and its subsidiary YFY Jupiter, Inc. (hereinafter called THE LICENSEE), located at 1528 WEST ADAMS STREET, 4TH FL., CHICAGO, ILLINOIS, U.S.A.

The first undersigned, CHIU, HSIU-YING, the representative of THE LICENSOR, does hereby declare on behalf of THE LICENSOR that THE LICENSOR is the legal proprietor of the U.S.A. registered trademark No. 3807950 in Class 042, and that THE LICENSOR hereby licenses THE LICENSEE, to use the said registered trade mark in the United States of America.

The second undersigned, Jeff Schachtner, the representative of THE LICENSEE does hereby declare on behalf of THE LICENSEE that THE LICENSEE hereby accepts said license of trade mark and shall act according to the terms and conditions of this agreement.

THE LICENSOR does hereby license THE LICENSEE the right to use the above-mentioned trademark on all the services covered by the above-mentioned trademark registration from the above-mentioned effective day of the license to the expiry day of the relevant registration.


This agreement of license is concluded by THE LICENSOR and THE LICENSEE in accordance with the provision of Article 33 of the Trademark Law.

It is hereby agreed by both THE LICENSOR and THE LICENSEE that THE LICENSEE should send at least 2 pieces of LICENSEE'S products concerned to THE LICENSOR for THE LICENSOR'S inspection, so that the products should be kept at the same quality as THE LICENSOR'S products at any time. Also THE LICENSEE shall indicate the licensing of the mark on his goods.

Should one party violate this agreement, the other party is entitled to terminate this agreement by giving a written notice of its intention to do so. Such intention shall take effect three months after it is given.

The above-mentioned terms and conditions are concluded, agreed and shall be prosecuted by both THE LICENSOR and THE LICENSEE.
