RELEASE OF SUPPLEMENTAL SECURITY INTEREST IN INTELLECTUAL PROPERTY

This RELEASE OF SUPPLEMENTAL SECURITY INTEREST IN INTELLECTUAL PROPERTY ("Release"), dated as of November 28, 2011, is made by Wells Fargo Bank, National Association, successor by merger to Wachovia Bank, National Association, as administrative agent and security trustee for the banks and other financial institutions (collectively, the "Lenders") party to the Credit Agreement referred to below (in such capacity, the "Administrative Agent"), for the benefit of the Secured Parties (as defined in the Domestic Pledge and Security Agreement referred to below), in favor of Unifrax I LLC ("Unifrax"). Except as otherwise provided herein, capitalized terms used herein without definition shall have the meanings given to them in the Credit Agreement referred to below.

WHEREAS, reference is made to the Credit Agreement, dated as of May 2, 2006 (as amended, modified or supplemented from time to time, the "Credit Agreement"), among UFX Holding II Corporation, Unifrax Holding Co., Unifrax Corporation and their subsidiaries and affiliates parties thereto, the Lenders and Agents from time to time parties thereto, and the Administrative Agent, pursuant to which Lenders provided for the availability of certain credit facilities to the Borrowers upon the terms and subject to the conditions set forth therein;

WHEREAS, in connection with the Credit Agreement, and pursuant to that certain Domestic Pledge and Security Agreement dated May 2, 2006 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Domestic Pledge and Security Agreement") and that certain IP Security Agreement Supplement dated May 30, 2007 (the "IP Security Agreement Supplement"), Unifrax granted to the Administrative Agent a security interest in certain Collateral, including but not limited to, the patents and patent applications set forth in Schedule A hereto (the "Patents"), the trademark and service mark registrations and applications set forth in Schedule B hereto (the "Trademarks") and the copyright registrations and applications set forth in Schedule C hereto (the "Copyrights"), which Intellectual Property Security Agreement was recorded in the United States Patent and Trademark Office on June 12, 2007 at Reel/Frame Nos. 019420/0564 and 3559/0788.

WHEREAS, Unifrax has requested that the Administrative Agent release its security interest in the Collateral, including the Patents, Trademarks and Copyrights; and

WHEREAS, the Administrative Agent has agreed to terminate and release the entirety of its security interest in and to Unifrax's Collateral, including the Patents, Trademarks and Copyrights.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Administrative Agent hereby **RELEASES** any and all of its security interest in the Collateral, including the Patents, Trademarks and Copyrights.


