INTELLECTUAL PROPERTY SECURITY AGREEMENT

This INTELLECTUAL PROPERTY SECURITY AGREEMENT (as amended, amended and restated, supplemented or otherwise modified from time to time, the “IP Security Agreement”) dated November 28, 2011, is made by the Persons listed on the signature pages hereof (collectively, the “Pledgors”) in favor of Goldman Sachs Lending Partners LLC, as administrative agent and security trustee for the banks and other financial institutions (collectively, the “Lenders”) party to the Credit Agreement referred to below (in such capacity, the “Administrative Agent”), for the benefit of the Secured Parties (as defined in the Domestic Security Agreement referred to below). Except as otherwise provided herein, capitalized terms used herein without definition shall have the meanings given to them in the Credit Agreement referred to below.

WHEREAS, reference is made to the Credit Agreement, dated as of November 28, 2011 (as amended, modified or supplemented from time to time, the “Credit Agreement”), among UFX Holding II Corporation, Unifrax Holding Co., Unifrax I LLC, Unifrax UK Holdco Limited, Unifrax Limited, Unifrax GmbH, and their subsidiaries and affiliates parties thereto, the Lenders and Agents from time to time parties thereto, and the Administrative Agent, which provides for the availability of certain credit facilities to the Borrowers upon the terms and subject to the conditions set forth therein.

WHEREAS, as a condition to the extension of credit to the Borrowers under the Credit Agreement, each Pledgor has executed and delivered that certain Domestic Security Agreement dated November 28, 2011 made by the Pledgors to the Administrative Agent (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Domestic Security Agreement”).

WHEREAS, under the terms of the Domestic Security Agreement, the Pledgors have granted to the Administrative Agent, for the ratable benefit of the Secured Parties, a security interest in, among other property, certain intellectual property of the Pledgors, and have agreed as a condition thereof to execute this IP Security Agreement for recording with the U.S. Patent and Trademark Office, the United States Copyright Office and other governmental authorities.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Pledgor agrees as follows:

SECTION 1. Grant of Security. Each Pledgor hereby grants to the Administrative Agent for the ratable benefit of the Secured Parties a security interest in all of such Pledgor’s right, title and interest in and to the following (the “Collateral”):

- (a) the patents and patent applications set forth in Schedule A hereto (the “Patents”);
- (b) the trademark and service mark registrations and applications set forth in Schedule B hereto (provided that no security interest shall be granted in United States

intent-to-use trademark applications to the extent that, and solely during the period in which, the grant of a security interest therein would impair the validity or enforceability of such intent-to-use trademark applications under applicable law), together with the goodwill symbolized thereby (the “Trademarks”);

(c) all copyrights, whether registered or unregistered, now owned or hereafter acquired by such Pledgor, including, without limitation, the copyright registrations and applications set forth in Schedule C hereto (the “Copyrights”):

(d) all reissues, divisions, continuations, continuations-in-part, extensions, renewals and reexaminations of any of the foregoing, and all rights corresponding thereto throughout the world;

(e) all claims and rights to recover for past, present and future infringement or dilution of or injury with respect to any of the foregoing; and

(f) any and all Proceeds (as defined in the Domestic Security Agreement) of or arising from any of the foregoing.

**SECTION 2. Security for Obligations.** The grant of a security interest in the Collateral by each Pledgor under this IP Security Agreement secures the full and prompt payment, at any time and from time to time as and when due (whether at the stated maturity, by acceleration or otherwise), of all liabilities and obligations of each Pledgor, whether now existing or hereafter incurred, created or arising and whether direct or indirect, absolute or contingent, due or to become due, under, arising out of or in connection with the Credit Agreement, the Domestic Security Agreement, the Domestic Subsidiary Guaranty, the Parent Guaranty or any of the other Credit Documents to which it is or hereafter becomes a party, or any Hedge Agreement required or permitted under the Credit Agreement and to which UFX Holdings II, Unifrax Holdco or any Subsidiary and any Lender or Affiliate of any Lender are parties. Upon any sale or other disposition by any Pledgor of any Collateral in a transaction permitted under the Credit Agreement or any other applicable Credit Document, the Lien and security interest created by this IP Security Agreement in and upon such Collateral shall be automatically released, and upon the satisfaction of all of the Termination Requirements, this IP Security Agreement and the Lien and security interest created hereby shall automatically terminate.

**SECTION 3. Recordation.** Each Pledgor authorizes and requests that the Register of Copyrights, the Commissioner for Patents and the Commissioner for Trademarks and any other applicable government officer record this IP Security Agreement.

**SECTION 4. Execution in Counterparts.** This IP Security Agreement may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.

**SECTION 5. Grants, Rights and Remedies.** This IP Security Agreement has been entered into in conjunction with the provisions of the Domestic Security Agreement. Each Pledgor does hereby acknowledge and confirm that the grant of the security interest hereunder to, and the rights and remedies of, the Administrative Agent with respect to the Collateral are more fully set forth in the Domestic Security Agreement, the terms and provisions of which are

incorporated herein by reference as if fully set forth herein. In the event that any provision of this IP Security Agreement is deemed to conflict with the Domestic Security Agreement, the provisions of the Domestic Security Agreement shall control.

SECTION 6. Governing Law. THIS IP SECURITY AGREEMENT AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HEREUNDER SHALL BE GOVERNED BY, AND CONSTRUED AND ENFORCED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK WITHOUT REGARD TO THE CONFLICTS OF LAW PROVISIONS THEREOF.


