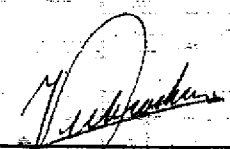

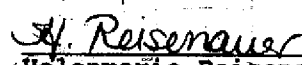
(b) To effect the foregoing, Article FIRST
