THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN U.S. TRADEMARKS (the "*Trademark Termination and Release*") dated as of November 9, 2011, from CAPITAL ONE, NATIONAL ASSOCIATION, a national banking association (f/k/a HIBERNIA NATIONAL BANK), as agent for the ratable benefit of the Lenders (the "*Agent*") pursuant to a Trademark Security Agreement (the "*Security Agreement*") dated as of May 27, 1999 between SAZERAC COMPANY, INC. (the "*Grantor*") and the Agent.

WITNESSETH:

WHEREAS, pursuant to the Security Agreement, a security interest (the "*Security Interest*") was granted by the Grantor to the Agent in certain collateral, including the Trademark Collateral (as hereinafter defined); and

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on March 17, 2000 at Reel 002035, Frame 0130; and

WHEREAS, the Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

1. Definitions. The term "*Trademark Collateral*", as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the Trademark Collateral (as defined in the Security Agreement), including, without limitation, those items listed on Exhibit A hereto.

2. Release of Security Interest. The Agent hereby terminates, releases and discharges its Security Interest in the Trademark Collateral without representation, warranty or recourse of any kind or nature.
