NOTICE OF TERMINATION OF
ACKNOWLEDGMENT OF INTELLECTUAL COLLATERAL PROPERTY LIEN

Reference is made to that certain Acknowledgment of Intellectual Property Collateral Lien dated as of August 6, 2003, as amended by that certain First Amendment to Acknowledgment of Intellectual Property Collateral Lien dated as of January 23, 2006 (the "Intellectual Property Agreement") made by each of **Tower Cleaning Systems, Inc.**, a Pennsylvania corporation and **USM Holdings, Corp.**, a Delaware corporation (each a "Grantor", and collectively with the Borrower, the "Grantors"), in favor of **CapitalSource Finance LLC**, a Delaware limited liability company, as administrative agent and collateral agent for certain Lenders (in such capacities, "Secured Party"). WHEREAS, Secured Party wishes to provide a document suitable for recording in the United States Patent and Trademark Office for purposes of recording the release, relinquishment and discharge of its security interests in and to the Intellectual Property Collateral granted by Grantors to Secured Party under and pursuant to the Intellectual Property Agreement and other Loan Documents.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Secured Party hereby relinquishes, releases and discharges its security interest in and to the Intellectual Property Collateral.
