**TERMINATION AND RELEASE
OF SECURITY INTEREST IN TRADEMARKS**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Termination and Release") dated as of December 1, 2011, from GE BUSINESS FINANCIAL SERVICES, INC. (successor-in-interest to Merrill Lynch Business Financial Services Inc.), in its capacity as Administrative Agent (in such capacity, together with its successors and permitted assigns, the "Agent") for the Lenders party to the Amended and Restated Credit and Security Agreement, dated as of February 7, 2008 (as amended, restated, supplemented, or otherwise modified from time to time, the "Credit Agreement"), to BIOLOK INTERNATIONAL INC., a Delaware corporation having a place of business at 312 South Military Trail, Deerfield Beach, Florida 33442; BIOHORIZONS IMPLANT SYSTEMS, INC. a Delaware corporation having a place of business at 2300 Riverchase Center, Birmingham, Alabama 35244; and ORTHOGEN CORPORATION a New Jersey Corporation having a place of business at 505 Morris Avenue #4, Springfield, New Jersey 07081 (collectively the "Grantors").

WITNESSETH:

WHEREAS, pursuant to the Credit Agreement, certain other Security Documents (as defined in the Credit Agreement), the Trademark Security Agreement dated as of April 18, 2007, in favor of Agent (the "Original Trademark Security Agreement"), and the Amended and Restated Trademark Security Agreement dated as of February 7, 2008 in favor of Agent (the "A&R Trademark Security Agreement" and together with the Original Trademark Security Agreement, collectively the "Trademark Security Agreements") a security interest (the "Security Interest") was granted by Grantors to Agent in the Trademarks (as defined in the Trademark Security Agreements);

WHEREAS, the Original Trademark Security Agreement was recorded with the Assignment Division of the United States Patent and Trademark Office on May 7, 2007, at Reel 3536, Frame 0777;

WHEREAS, the A&R Trademark Security Agreement was recorded with the Assignment Division of the United States Patent and Trademark Office on February 29, 2008, at Reel 3729, Frame 0168; and

WHEREAS, Agent now desires to terminate and release the entirety of its Security Interest in the Trademarks.

NOW, THEREFORE, for good and valuable consideration, including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademarks pursuant to the Credit Agreement, the Security Documents, and the Trademark Security Agreements, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, Agent hereby states as follows:


1. Definitions. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Credit Agreement and the Trademark Security Agreements.

2. Release of Security Interest. Agent hereby terminates, releases, and discharges its Security Interest in the Trademarks, including the registered trademarks and trademark applications listed in Schedule 1 attached hereto. To the extent that Agent has any right, title, or interest in such Trademarks and proceeds thereof under the Credit Agreement, the Security Documents, and the Trademark Security Agreements, including without limitation, any and all causes of action which may exist by reason of infringement of the Trademarks, such right, title, or interest shall hereby cease and become void.
