THIS INSTRUMENT AND THE RIGHTS AND OBLIGATIONS EVIDENCED HEREBY AND ANY SECURITY INTERESTS OR OTHER LIENS SECURING SECURED OBLIGATIONS ARE SUBORDINATE IN THE MANNER AND TO THE EXTENT SET FORTH IN THAT CERTAIN INTERCREDITOR AND SUBORDINATION AGREEMENT (THE "INTERCREDITOR AGREEMENT") DATED AS OF NOVEMBER 16, 2011 AMONG JPMORGAN CHASE BANK, N.A. (TOGETHER WITH ITS SUCCESSORS AND ASSIGNS, THE "SENIOR LENDER"), CAPITALSOUTH PARTNERS FUND II LIMITED PARTNERSHIP, CAPITALSOUTH PARTNERS SBIC FUND III, L.P., THE CHEF'N CORPORATION ("CHEF'N"), AND CHEF'N ACQUISITION, INC. ("HOLDCO" AND TOGETHER WITH CHEF'N, COLLECTIVELY, JOINTLY AND SEVERALLY, THE "BORROWER"), TO THE INDEBTEDNESS (INCLUDING INTEREST) OWED BY BORROWER PURSUANT TO THAT CERTAIN AMENDED AND RESTATED CREDIT AGREEMENT (THE "CREDIT AGREEMENT") DATED AS OF NOVEMBER 16, 2011 AMONG THE BORROWER AND THE SENIOR LENDER AS SUCH CREDIT AGREEMENT AND OTHER LOAN DOCUMENTS (AS DEFINED IN THE CREDIT AGREEMENT) MAY BE AMENDED, RESTATED, SUPPLEMENTED OR OTHERWISE MODIFIED FROM TIME TO TIME AND TO INDEBTEDNESS REFINANCING THE INDEBTEDNESS THEREUNDER AS CONTEMPLATED BY THE INTERCREDITOR AGREEMENT; AND EACH HOLDER OF THIS INSTRUMENT, BY ITS ACCEPTANCE HEREOF, IRREVOCABLY AGREES TO BE BOUND BY THE PROVISIONS OF THE INTERCREDITOR AGREEMENT.

SECOND LIEN PATENT AND TRADEMARK SECURITY AGREEMENT

THIS PATENT AND TRADEMARK SECURITY AGREEMENT (as it may be amended or modified from time to time, this "**Agreement**"), dated as of November 16, 2011, by The Chef'n Corporation, a Washington corporation ("**Chef'n**"), Chef'n Acquisition, Inc., an Indiana corporation ("**Chef'n Acquisition**" and together with Chef'n, jointly and severally, the "**Borrower**"), and the Loan Parties party hereto from time to time (Borrower and Loan Parties, collectively, referred to herein as "**Grantor**"), in favor of CapitalSouth Partners Fund II Limited Partnership, a North Carolina limited partnership ("**CapitalSouth**"), and CapitalSouth Partners SBIC Fund III, L.P., a Delaware limited partnership ("**CapitalSouth SBIC**" and together with CapitalSouth, the "**Purchasers**" and each individually, a "**Purchaser**"). Capitalized terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Pledge and Security Agreement (defined below).

W I T N E S S E T H:

WHEREAS, pursuant to that certain Note Purchase Agreement dated as of even date herewith by and among Borrower, the other Loan Parties party thereto, and the Purchasers (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, supplemented or otherwise modified, the "**Purchase Agreement**"), the Purchasers have agreed to make loans to Borrower;

WHEREAS, the Purchasers are willing to make certain financial accommodations as provided for in the Purchase Agreement, but only upon the condition, among others, that Grantor shall have executed and delivered to the Purchasers that certain Pledge and Security Agreement dated as of even date herewith (including all annexes, exhibits or schedules thereto, as from time

to time amended, restated, supplemented or otherwise modified, the “**Pledge and Security Agreement**”); and

WHEREAS, pursuant to the Pledge and Security Agreement, Grantor is required to execute and deliver to the Purchasers this Agreement;

NOW, THEREFORE, in consideration of the premises and mutual covenants herein contained and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantor hereby agrees as follows:

1. DEFINED TERMS. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Pledge and Security Agreement.

2. GRANT OF SECURITY INTEREST IN PATENT COLLATERAL. Grantor hereby grants to the Purchasers a continuing security interest in all of Grantor’s right, title and interest in, to and under the following, and all rights, title and interest corresponding to any of the following throughout the world, whether presently existing or hereafter created or acquired (collectively, the “**Patent Collateral**”):

(a) all Patents, non-U.S. patents, design patents, industrial designs, petty patents, and utility models, referred to in Schedule A hereto (collectively, the “**Patents**”);

(b) all inventions and discoveries described in any of the Patents and all related technology, whether patentable or not, including but not limited to, invention disclosures, improvements, trade secrets, proprietary information, know how, technology, technical data, designs, methods, processes, ideas, and all documentation or notations embodying or evidencing any of the foregoing that describe, claims and/or relate to any such inventions and/or all forms of legal rights and protections that may be obtained for or may pertain to, such inventions in any country of the world (“**Inventions**”);

(c) any applications for patents and non-U.S. patents (including provisional patent and non-U.S. patent applications), that describe, claim and/or relate to any Inventions, referred to in Schedule A hereto (“**Patent Applications**”);

(d) all patents and patent applications, and non-U.S. patents and non-U.S. patent applications, sharing the priority of any Patent or Patent Application, including all continuations, continuations-in-part, divisions, patents of addition, confirmations, reissues, renewals, extensions, and equivalents or counterparts thereof anywhere in the world (“**Extensions**”);

(e) all patent, design patent, industrial design, petty patent, utility model, patent application (including any provisional patent application) incorporated by reference by or into, cross-referenced by, having substantially the same specification as, and/or terminally disclaimed for or against, any Patent, Patent Application or Extension (“**Related Patents and Applications**”);

(f) all Licenses providing for the grant by or to the Grantor of any right under any of its Patents (the "**Patent Licenses**"), including those Patents and Patent Applications referred to in Schedule A hereto;

(g) all goodwill of the business connected with the use of each such Patent;
and

(h) all income, royalties, damages, claims, and payments now or hereafter due or payable under and with respect to, including, without limitation, any claim by the Grantor against third parties for past, present or future (i) infringement or dilution of any such Patent or any Patent licensed under a Patent License or (ii) injury to the goodwill associated with any such Patent or any Patent licensed under a Patent License; provided that no security interest shall be granted in any United States patent application to the extent that, and solely during the period in which, the grant of a security interest therein would impair the validity or enforceability of such patent application under applicable federal law.

3. GRANT OF SECURITY INTEREST IN TRADEMARK COLLATERAL.

Grantor hereby grants to the Purchasers a continuing security interest in all of Grantor's right, title and interest in, to and under the following, and all rights, title and interest corresponding to any of the following throughout the world, whether presently existing or hereafter created or acquired (collectively, the "**Trademark Collateral**"):

(a) all of its Trademarks and all Licenses providing for the grant by or to Grantor of any right under any of its Trademarks (the "**Trademark Licenses**"), including those registered Trademarks referred to in Schedule B hereto;

(b) all reissues, continuations or extensions of the foregoing;

(c) all goodwill of the business connected with the use of, and symbolized by, each such Trademark; and

(d) all income, royalties, damages, claims, and payments now or hereafter due or payable under and with respect to, including, without limitation, any claim by Grantor against third parties for past, present or future (i) infringement or dilution of any such Trademark or any Trademark licensed under a Trademark License or (ii) injury to the goodwill associated with any such Trademark or any Trademark licensed under a Trademark License; provided that no security interest shall be granted in any United States "intent to use" trademark application to the extent that, and solely during the period in which, the grant of a security interest therein would impair the validity or enforceability of such "intent to use" trademark application under applicable federal law.

4. PLEDGE AND SECURITY AGREEMENT. The security interests granted pursuant to this Agreement are granted in conjunction with the security interests granted to the Purchasers pursuant to the Pledge and Security Agreement. Grantor hereby acknowledges and affirms that the rights and remedies of the Purchasers with respect to the security interest in the Patent Collateral and the Trademark Collateral made and granted hereby are more fully set forth

in the Pledge and Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.

5. AUTHORIZATION TO SUPPLEMENT. If Grantor shall obtain rights to any new Patents or Trademarks, the provisions of this Agreement shall automatically apply thereto. Grantor shall give prompt notice in writing to the Purchasers with respect to any such new Patents or Trademarks. Without limiting any Grantor's obligations under this Section 5, Grantor hereby authorizes the Purchaser to unilaterally modify this Agreement by amending Schedules A and B to include any such new Patent and Trademark rights of Grantor. Notwithstanding the foregoing, no failure to so modify this Agreement or amend Schedules A and B shall in any way affect, invalidate or detract from the continuing second priority security interest of the Purchasers in all Collateral, whether or not listed on Schedules A and B.

6. COUNTERPARTS. This Agreement may be executed in any number of counterparts, each of which shall be deemed to be an original, but all such separate counterparts shall together constitute but one and the same instrument. In proving this Agreement or any other Loan Document in any judicial proceedings, it shall not be necessary to produce or account for more than one such counterpart signed by the party against whom such enforcement is sought. Any signatures delivered by a party by facsimile transmission or by e-mail transmission shall be deemed an original signature hereto.

7. INTERCREDITOR AGREEMENT. Notwithstanding anything in this Agreement to the contrary, Grantor and Purchasers hereby acknowledge and agree for the express benefit of Senior Lender that this Agreement, the security interests granted to Purchasers hereunder, and Purchasers' rights and remedies in and to the Patent Collateral and Trademark Collateral (including without limitation during any period during which an Event of Default has occurred and is continuing) shall, prior to the discharge of the Senior Debt, be subject and subordinate (pursuant to the terms and conditions of the Intercreditor Agreement) to the first priority security interest granted to the Senior Lender to secure the Senior Debt pursuant to the Senior Credit Agreement. Notwithstanding anything herein to the contrary, until the discharge of the Senior Debt, the encumbrances and security interest granted to the Purchasers pursuant to this Agreement and the exercise of any right or remedy by the Purchasers hereunder are subject in all instances to the provisions of the Intercreditor Agreement, and in the event of any conflict between the terms of the Intercreditor Agreement and this Agreement, the terms of the Intercreditor Agreement shall govern and control (provided, however, notwithstanding anything in this Agreement (including this Section 7) to the contrary, any limitation on the exercise of any right or remedy by the Purchasers under this Agreement pursuant to the provisions of the Intercreditor Agreement shall be enforceable solely and exclusively by Purchasers, and not by Grantor).
