

## DECLARATION OF ASSIGNMENT

Declarant, Richard L. Lindsay, states as follows:

1. I am Secretary and Treasurer for Syrgis Performance Initiators, Inc., ("SPI") and have held this position since August 17, 2007.
2. Upon information and belief, on August 17, 2007, SPI, Syrgis Acquisition AB, and Norac, Inc. ("Seller") entered into a certain Stock and Asset Purchase Agreement ("Agreement"). This Agreement controlled the acquisition of Seller's organic peroxide business, run directly or indirectly through the Seller and its wholly owned subsidiary, Norac Andos AB, by SPI and Syrgis Acquisition AB. As of the closing date of the Agreement, August 31, 2007, SPI received all of Seller's right, title and interest in and to all assets, rights and properties of every nature, kind and description primarily used in or held for use in the organic peroxide business, including U.S. Trademark Registration No. 3,123,744, owned by Norac Andos AB.
3. Upon information and belief, a valid transfer of legal title has occurred and SPI is the proper owner of U.S Trademark Registration No. 3,123,744 for the mark ANDONOX and the goodwill associated therewith.
4. I further declare that all statements made herein of my own knowledge are true and that all statements made on information and belief are believed to be true; and that these statements are made with the knowledge that willful false statements and the like so made are punishable by fine or imprisonment, or both, under section 1001 of Title 18 of the United States Code, and that such willful false statements may jeopardize the validity of the application and/or document or any registration resulting therefrom.
