**ARTICLES OF AMENDMENT TO THE
ARTICLES OF ORGANIZATION OF
OJALA, L.L.C.**

BE IT KNOWN, that on this 28th day of November, 2011 personally came and appeared before me, the undersigned Notary Public, the individual named below, being a duly authorized officer of Take 5 Oil Change, Inc., a Delaware corporation and the sole manager of Ojala, L.L.C., which hereby adopts the following Articles of Amendments to the Articles of Organization of Ojala, L.L.C., as follows:

ARTICLE I.

The name of this limited liability company is Ojala, L.L.C.

ARTICLE II.

The following amendments to the Articles of Organization of Ojala, L.L.C. were adopted by the written consent of the sole member of Ojala, L.L.C. effective as of November 28, 2011.

1. Article I of the Articles of Organization of this limited liability company is hereby amended and restated to read in its entirety as follows:

**"ARTICLE I
NAME**

The name of this limited liability company is Take 5 Oil Change, L.L.C. (hereinafter referred to as the "Company")."

2. Article III of the Articles of Organization of this limited liability company is hereby amended and restated to read in its entirety as follows:

**"ARTICLE III
MANAGEMENT BY MANAGER**

All powers of the Company are vested solely in, and all of the business and affairs of the Company shall be managed by, its sole manager, Take 5 Oil Change, Inc. (hereinafter referred to as the "Managing Member" or "Manager")."


3. Article IV of the Articles of Organization of this limited liability company is hereby amended and restated to read in its entirety as follows:

EVIDENCE OF AUTHORITY**






