**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of December 1, 2011 ("Release"), is made by BANK OF AMERICA, N.A., as administrative agent (the "Administrative Agent") in favor of AZPB LIMITED PARTNERSHIP, a Delaware limited partnership (the "Grantor").

WHEREAS, pursuant to that certain Security and Pledge Agreement dated as of December 14, 2005 (as amended, modified, extended or restated from time to time, the "Security Agreement") by and among the Obligors party thereto and the Administrative Agent, each Obligor granted to the Administrative Agent, for the ratable benefit of the holders of the Secured Obligations, a continuing security interest in and continuing lien upon, any and all right, title and interest of such Obligor in and to all Trademarks, all Trademark Licenses, and all Proceeds of the foregoing;

WHEREAS, pursuant to the Security Agreement, Grantor, an Obligor executed and delivered to Administrative Agent, for the ratable benefit of the holders of the Secured Obligations, the Notice of Grant of Security Interest in Trademarks dated as of December 14, 2005 ("Notice"); and

WHEREAS, the Notice was recorded at the United States Patent and Trademark Office ("USPTO") on January 9, 2006 at Reel 003223 Frame 0007.

NOW THEREFORE, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Administrative Agent, on behalf of the holders of the Secured Obligations, and Grantor (the "parties") agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Notice.

SECTION 2. Termination and Release. Administrative Agent, on behalf of the holders of the Secured Obligations, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the mortgage, pledge, and hypothecation and lien on and security interest in and to the right, title, and interest in, to, and under all Trademarks, all Trademark Licenses, and all Proceeds of the foregoing, including the foregoing listed on Schedule A attached hereto, granted pursuant to the Security Agreement; and

(b) authorizes the recordation of this Release with the USPTO.

IN WITNESS WHEREOF, the Administrative Agent, on behalf the Secured Parties, has caused this Termination and Release of Security Interest in Trademarks to be duly executed as of the date first set forth above.
