

### **ARTICLE III** **Merged Corporation**

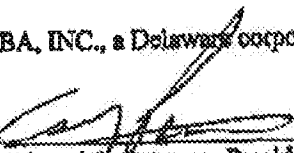
