These Amended and Restated Articles of Incorporation (i) have been duly adopted by the Corporation's Board of Directors and sole shareholder in accordance with the applicable provisions of Sections 16-10a-1006 and 1007 of the Utah Revised Business Corporation Act (the "URBCA"); and (ii) supersede the original Articles of Incorporation of the Corporation and all amendments and restatements thereto in their entirety.

Pursuant to, and in accordance with, Section 16-10a-1007 of the URBCA, ReminderBand, Inc., a Utah corporation (the "Corporation") adopts the following Amended and Restated Articles of Incorporation:

**ARTICLE 1
NAME**

The name of the Corporation is iFrogz Inc. (the "Corporation").

**ARTICLE 2
PURPOSES AND POWERS**

The Corporation is organized to engage in any and all lawful acts, activities and/or pursuits for which corporations may presently or hereafter be organized under the URBCA.

The Corporation shall have all powers allowed by law, including without limitation those powers described in Section 16-10a-302 of the URBCA. The purposes stated herein shall be construed as powers as well as purposes and the enumeration of a specific purpose or power shall not be construed to limit or restrict the meaning of general terms or the general powers, nor shall the expression of one thing be deemed to exclude another not expressed, although it be of like nature.

**ARTICLE 3
REGISTERED OFFICE AND AGENT**

The address of the registered office of the Corporation in the State of Utah is:

**ARTICLE 4
PRINCIPAL PLACE OF BUSINESS**

The street address of the principal place of business of the Corporation is:

**ARTICLE 5
AUTHORIZED SHARES**

The aggregate number of shares that the Corporation shall have authority to issue is One Hundred Thousand (100,000) shares of common stock, \$.001 par value per share. All voting rights of the Corporation shall be exercised by the shareholders of the common stock of the Corporation, and the shareholders of the common stock of the Corporation shall be entitled to receive the net assets of the Corporation upon dissolution. All shares of the common stock shall be fully paid and nonassessable.

**ARTICLE 6
OFFICER AND DIRECTOR LIABILITY**

The Corporation shall indemnify and advance expenses to its directors, officers, employees, fiduciaries or agents and to any person who is or was serving at the Corporation's request as a director, officer, partner, trustee, employee, fiduciary or agent of another domestic or foreign corporation or other person or of an employee benefit plan (and then-respective estates or personal representatives) to the fullest extent as from time to time permitted by the Act or other applicable Utah law.

The personal liability of the directors and officers of the Corporation to the Corporation or its shareholders, or to any third person, shall be eliminated or limited to the fullest extent as from time to time permitted by the Act or other applicable Utah law.

Any repeal or modification of this Article 6 by the shareholders of the Corporation shall not adversely affect any right or protection of any person existing at the time of such repeal or modification.

**ARTICLE 7
RESTATEMENT OF ARTICLES OF INCORPORATION**


These Amended and Restated Articles of Incorporation supersede the original Articles of Incorporation and all amendments thereto. Authority was given to the officers of the Corporation named herein to file these Amended and Restated Articles of Incorporation with the Utah State Department of Commerce, Division of Corporations and Commercial Code pursuant to (i) the written consent of the Board of Directors of the Corporation effective as of July 7, 2011, and (ii) the written consent of the sole shareholder of the Corporation effective as of July 7, 2011 in accordance with the Section 16-10-1006 as follows:

At the time of the adoption of the foregoing Amended and Restated Articles of Incorporation, the Corporation had one class of shares outstanding, designated as common stock, of which a total of Sixty-Seven Thousand Five Hundred Eighty-Six (67,586) shares were issued and outstanding, and all of which were entitled to vote thereon as a single class. The number of shares of common stock that voted to approve the foregoing Amended and Restated Articles of Incorporation was Sixty-Seven Thousand Five Hundred Eighty-Six (67,586), which is sufficient for the approval of the foregoing Amended and Restated Articles of Incorporation. No votes were cast against the amendment and restatement.

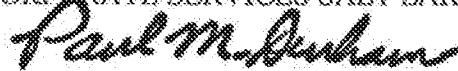
