TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of November 30 2011, by BANK OF MONTREAL, as Administrative Agent ("Agent"), with its mailing address at 111 West Monroe Street, Chicago, Illinois 60603. Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

WITNESSETH:

WHEREAS, BSERV INTERNET PAYMENTS, INC., a Nevada corporation ("Grantor"), with its principal place of business and mailing address at 8350 South Durango Drive, Suite 140, Las Vegas, Nevada 89113, and Agent were parties to a Trademark Security Agreement dated as of August 24, 2011 (the "Security Agreement"), pursuant to which Grantor granted a Lien on and continuing security interest to Agent in all of Grantor's right, title and interest in, to and under the Trademark Collateral (as defined below) as security for certain obligations owing by Grantor to Agent; and

WHEREAS, the Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on August 25, 2011, at Reel 4611, Frame 0368; and

WHEREAS, Grantor has requested that Agent release its Lien on and continuing security interest in the Trademark Collateral and assign any and all rights in the same to the Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases its Lien on and continuing security interest in all of Grantor's right, title and interest in and to the following (collectively the "Trademark Collateral"): .

(i) all of its trademarks and trademark applications, including, without limitation, each trademark and trademark application listed on Schedule A hereto, and all renewals and extensions of the foregoing;

(ii) all goodwill of the business connected with the use of, and symbolized by, each such trademark and trademark application; and

(iii) all income, royalties and proceeds of the foregoing at any time due or payable or asserted under and with respect to the foregoing, including, without limitation, any claim by Grantor against third parties for damages by reason of past, present or future infringement of any trademark or trademark application, in each case together with the right to sue for and collect said damages;

2. If and to the extent Agent retains any interest in the Copyright Collateral, Agent hereby assigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Agent, any and all of Agent's right, title and interest, now owned or hereafter acquired, that it may have whether by assignment or otherwise, in and to the Trademark Collateral.
