RELEASE OF SECURITY INTEREST IN AND LIEN ON TRADEMARKS

This Release of Security Interest in and Lien on Trademarks ("Trademark Release"), dated as of December 5, 2011, is made by Wilmington Trust, National Association, as successor to Wilmington Trust FSB, as collateral agent (the "Collateral Agent"), in favor of Niagara LaSalle Corporation (the "Company"), as successor by merger to Niagara Corporation ("Niagara"), LaSalle Steel Company ("LaSalle Steel") and Plymouth Steel Corporation ("Plymouth Steel").

WHEREAS, pursuant to the Guaranty and Security Agreement, dated as of March 31, 2010 (as amended, restated, modified, supplemented or replaced from time to time, the "Security Agreement"; capitalized terms used herein but not defined herein having the meanings ascribed to such terms in the Security Agreement), among the Company, KNIA Holdings, Inc., each other Grantor from time to time party thereto (including Niagara, LaSalle Steel and Plymouth Steel) and the Collateral Agent, the Grantors granted to the Collateral Agent for the benefit of the Lenders and each other Secured Party a security interest in and lien on all right, title and interest of the Grantors in certain Trademark Collateral (as defined in the Trademark Security Agreements), including the Trademarks set forth on Schedule A attached hereto (the "2010 Trademark Collateral");

WHEREAS, the lien in the 2010 Trademark Collateral granted to the Collateral Agent for the benefit of the Lenders and each other Secured Party was recorded in the United States Patent and Trademark Office (the "USPTO") on April 15, 2010 at Reel 004186, Frame 0394 (with respect to LaSalle Steel as Grantor) and Reel 004186, Frame 0410 (with respect to Niagara as Grantor) and on July 2, 2010 at Reel 004236, Frame 0666 (with respect to Plymouth Steel as Grantor) (such recordals, collectively, the "Trademark Security Agreements");

WHEREAS, pursuant to the Agreement and Plan of Merger, dated as of December 30, 2010 (the "LaSalle Steel Merger"), between LaSalle Steel and the Company, LaSalle Steel merged with and into the Company with the Company as the surviving entity;

WHEREAS, pursuant to the Agreement and Plan of Merger, dated as of December 30, 2010 (the "Plymouth Steel Merger"), between Plymouth Steel and the Company, Plymouth Steel merged with and into the Company with the Company as the surviving entity;

WHEREAS, pursuant to the Agreement and Plan of Merger, dated as of January 7, 2011 (the "Niagara Merger"), between Niagara and the Company, Niagara merged with and into the Company with the Company as the surviving entity;

WHEREAS, the LaSalle Steel Merger or evidence thereof was recorded in the USPTO on October 6, 2011 at Reel 004636, Frame 0800;

WHEREAS, the Plymouth Steel Merger or evidence thereof was recorded in the USPTO on November 23, 2011 at Reel 004665, Frame 0877;

WHEREAS, the Niagara Merger or evidence thereof was recorded in the USPTO on November 23, 2011 at Reel 004665, Frame 0873; and

WHEREAS, pursuant to the Payoff Letter dated as of December 5, 2011, the Collateral Agent has agreed to evidence the release of any and all security interest in and lien on the 2010 Trademark Collateral held by the Collateral Agent for the benefit of the Lenders and each other Secured Party.

NOW, THEREFORE, in exchange for good and valuable consideration, the receipt of which is hereby acknowledged, the Collateral Agent agrees as follows:

1. The Collateral Agent hereby terminates, releases, relinquishes and discharges its Lien and mortgage on, the hypothecation and pledge to it of, and its security interest in, to and under the 2010 Trademark Collateral, in each case mortgaged, pledged, hypothecated or granted pursuant to the Security Agreement and/or the Trademark Security Agreements.

2. The Collateral Agent hereby authorizes and acknowledges the termination of the Security Agreement and the Trademark Security Agreements. At the Company's expense, the Collateral Agent hereby agrees to duly execute, acknowledge and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Lien and security interest contemplated hereby and terminate the Trademark Security Agreements.

3. This Trademark Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
