**STATEMENT**

Dominique, François, Margaretha Maria Zaman, civil law notary, officiating in Rotterdam, the Netherlands, declares that:

according to and solely based upon:

- (i) an original excerpt of the current registration of **deSter Holding B.V.**, a private limited liability company under the laws of the Netherlands (*besloten vennootschap met beperkte aansprakelijkheid*) having its statutory seat at Amsterdam, the Netherlands and its registered office at Duijvendrechtsekade 85, 1096AJ Amsterdam, the Netherlands (the "**Company**") registered in the Trade Register of the Chamber of Commerce in Amsterdam, the Netherlands (the "**Trade Register**") under number 33201067, dated as per the date hereof, the correctness and completeness of which I have assumed;
  - (ii) an on-line excerpt of the historical registration of the Company in the Trade Register, the correctness and completeness of which I have assumed;
  - (iii) a copy of a notarial deed of merger, executed on 30 January 2003 before E.M. Bijster, civil law notary in Vlaardingen, the Netherlands (the "**Deed of Merger**"), the validity of which I have assumed;
  - (iv) a copy of a notarial deed of amendment of the articles of association of the Company, executed on 12 December 2005 before D.F.M.M. Zaman, aforementioned; and
  - (v) an on-line excerpt of the historical registration of the De Ster B.V. (as mentioned below) in the Trade Register, the correctness and completeness of which I have assumed,
1. on 31 January 2003, the Company (at that time named De Ster ACS Holding B.V.) acquired, by operation of law pursuant to a legal merger contemplated by the Deed of Merger, all assets and liabilities of the following private companies with limited liability under the laws of the Netherlands (i) De Ster ACS Europe Holding B.V., (ii) De Ster ACS Investments B.V. and (iii) De Ster B.V. (at that time registered at Prinsengracht 168, 1016 HA Amsterdam, the Netherlands);
  2. on 12 December 2005, the statutory name of the Company was changed from De Ster ACS Holding B.V. into deSter Holding B.V.; and

- on 14 December 2005, the Company (at that time named De Ster ACS Holding B.V.) changed its registered address from Leewenveldseweg 16, 1382 LX Weesp, the Netherlands to Duivendrechtsekade 85, 1096 AJ Amsterdam, the Netherlands.
